1) FUNCTIONS OF THE EXECUTIVE COMMITTEE AND OFFICE BEARERS:

1. PRESIDENT: He presides over all the meetings of the Executive Committee. He can cast his vote in the case of a tie in decision making. He can supervise all branches of the Society.
2. VICE PRESIDENT: He shall assist the president in discharge his functions. In the absence of the president he will perform the duty of the president as entrusted by the president.
3. SECRETARY: He is the chief Executive Officer of the Society and custodian of all records relating to the society and correspondent on behalf of the society. He has to take on record all minutes of the Society. He would convene both the Executive committee and General Body of the Society with the permission of the president. He guides the Treasurer in preparing the budget and expenditure statement to place before the General Body for its approval.
4. JOINT SECRETARY: He has to do the work entrusted by the Executive Committee. He has to assist the Secretary in discharging his duties. In the absence of the Secretary, he can perform the duties of the Secretary.
5. TREASURER: He is responsible for all financial transactions and Funds of the Society. He has to maintain accounts of the society jointly with the Secretary or president.
6. OFFICE BEARERS: They are the responsible persons of attend to such activities of the society which the Executive committee entrusts to them.
7. QUORUM: Half of the total members for General Body Meeting and 1/4 for Executive Committee Meeting.
8. FUNDS: The funds shall be spent only for the attainment of the objects of the Society and no portion there of shall be paid or transferred directly or indirectly to any of the members through any means.
9. AMENDMENTS: No amendment or alteration shall be made in the purpose of the Association unless it is voted by 2/3 of its members present at a special meeting convened for the purpose and confirmed by 2/3 of the members present at a second special meeting.
10. WINDING UP: In case the society has to be wound up the property and funds of the society that remain after discharging the liabilities, if any, shall be transferred or paid to some other institutions with similar aims and object.

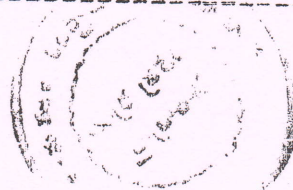
